## RAGGING IS

1. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
2. Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
3. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
4. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher;
5. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students;
6. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
7. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
8. Any act or abuse by spoken words, emails, posts, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student;
9. Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.



## ANTI RAGGING MEASURES AT M.D.COLLEGE

1. This is to inform all the students registering with M.D.College, Barabanki that Ragging in the campus is totally banned in all forms as per the directions of the Government of India which allows strict and punitive actions against the students found guilty of same.
2. It is mandatory for all the students to submit the Student Affidavit. Performa of the same can also be downloaded from [www.mdcollege.co.in](http://www.mdcollege.co.in). It should be on a Rupees Ten Stamp paper duly signed by them and the Oath commissioner.
3. It is mandatory for all the students to submit the Parent/Guardian Affidavit; Performa of the same can be downloaded from [www.mdcollege.co.in](http://www.mdcollege.co.in). It should be on a Rupees Ten Stamp paper duly signed by their Parent/Guardian and the oath commissioner. It must be submitted along with the Registration Form within two days of registering with the Institute.
4. Any student found guilty of ragging and/or abetting ragging is liable to be punished as per the orders of Government of India, Notification No. F.1-16/2007(CPP-II) dated 17th June 2009.
5. The Anti Ragging Committee of the Institution shall take an appropriate decision, with regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging.
6. Depending upon the nature and gravity of the offence as established the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:
  - a) Cancellation of admission;
  - b) Suspension from attending classes;
  - c) Withholding/withdrawing scholarship/fellowship and other benefits;
  - d) Debarring from appearing in any test/examination or other evaluation process;
  - e) Withholding results;
  - f) Debarring from representing the institution in any regional, national or International meet, tournament, youth festival, etc;
  - g) Rustication from the institution;
  - h) Expulsion from the institution and consequent debarring from Admission to any other institution;

## Grievance/Redressal Committee

### ROLES AND RESPONSIBILITIES OF THE COMMITTEE

1. The Committee shall receive the application/complaint from Students as well as teachers and acknowledge the receipt within 3 days.
2. The Committee shall study, analysis and submit its recommendations to the Director within 15 days from the date of receipt of application/complaint.
3. The recommendation submitted by the Grievance Redressal Committee shall be viewed and considered by Director. Director may consult Secretary if required before taking a decision and disposing of the Grievance/Petition.
4. The grievance needs to be redressed and disposed off as soon as possible however not exceeding 30 days from the date of receipt, in the case of employee and 60 days in the case of public.
5. However under circumstance a policy decision is warranted, the subject matter may be referred by Director to Chairman Governing Body with request for direction and guidance.
6. The Institute is in the process of redesigning its websites and shall incorporate the directives as received.

## Committee For SC/ST

### FUNCTION OF THE COMMITTEE

According to the UGC Guidelines of 1998, following are the functions of the Cell to:

- Circulate GOI and Commission's decisions and to collect regularly, on an annual basis, information regarding course-wise admissions to candidates belonging to the Scheduled Castes and Scheduled Tribes in the Universities and Colleges for different courses, in suitable forms prescribed, by a stipulated date, and to take follow up action, where required;
- Circulate GOI orders and Commission's decisions and to collect information in respect of appointment, training of these communities in teaching and nonteaching posts in the Universities and Colleges, in suitable forms by a stipulated date and take follow up action where required;
- Collect reports and information regarding the GOI orders on the various aspects of education, training and employment of Scheduled Caste and Scheduled Tribe candidates, for evolving new policies or modifying existing policy by the Commission;
- Analyse information on admissions, education, training and employment of SCs and STs, and prepare reports and digests for onward transmission to the Ministry of Human Resource Development/University Grants Commission and such other authorities as may be required;
- Deal with representations received from Scheduled Castes and Tribes candidates regarding their admission, recruitment, promotion and other similar matters in Universities/Colleges;
- Monitor the working of the remedial coaching scheme, if approved in the affiliated colleges and university;
- Function as a Grievances Redressal Cell for the grievances of SC/ST students and employees of the university and render them necessary help in solving their academic as well as administrative problems;
- Maintain a register for employment of SCs/STs in the University and Colleges for the candidates belonging to SC/ST community for various posts in the university/ colleges; and
- Any other work assigned from time to time to promote higher education among these two communities suffering economic, social and educational deprivations.
